

## **MINUTES**

### **CITY OF DELANO CITY COUNCIL – SPECIAL MEETING June 11, 2012**

#### **CALL TO ORDER**

Mayor Vallejo called the meeting to order at 5:16 p.m. in the City Hall Council Chambers, 1015 – Avenue.

#### **FLAG SALUTE**

Councilman Chavez led the flag salute.

#### **SPECIAL AGENDA ITEM**

- 1) Approval of request for continued sponsorship in the amount of \$3,000 for the annual Kiwanis Club Fireworks Spangled Spectacular July 3, 2012

Suzann Villaruz, speaking on behalf of the Kiwanis Club, stated the club did not win a spot in this year's drawing for the fireworks booths, nor did the Historical Society. In the past, these two clubs used monies earned at the booths to put on the fireworks display for the city. The Kiwanis Club is asking the city for \$3,000 towards the total cost of \$8,000 for the show.

Moved by Councilman Aguirre, seconded by Mayor Vallejo and unanimously carried to approve sponsorship in the amount of \$3,000 for the annual Kiwanis Club Fireworks show.

Mayor Vallejo stated she would like staff to prepare an ordinance to insure that the organization that puts on the community fireworks show will have a fireworks booth guaranteed.
