The applicant is requesting approval of a Combined Development Permit to allow a General Plan Map amendment from Industrial Land Use to Community Facility; amend the Official Zoning Map by rezoning the subject site from Industrial (I) Zoning District to Community Facilities (CF) Zoning District; and a conditional use permit to allow the construction and operation of a church on an existing 12.34 acre site. In addition, the Planning Commission will consider adopting the Mitigated Negative Declaration for the project, located on a 12.34 acre site adjacent to and west of State Route 99, north of 20th Avenue, easterly of Ellington Street. The project site is also bisected and southwest of the future extension of Glenwood Street, APN 410-040-05

Appeal Notice: Any person aggrieved by the decision of the Planning Commission may appeal the decision within ten (10) calendar days to the City Council. Any person may appeal a decision of the Planning Commission to the City Council where the Planning Commission's decision would otherwise be final. Appeal application forms are available at the office of the Community Development Department to all persons wishing to appeal an action included in this Title. Appeal applications shall be filed with the Community Development Department within ten (10) calendar days following the date of action for which an appeal is made unless otherwise provided. If the last day to file falls on a holiday or on a Saturday or Sunday, the following business day shall be deemed the last day to act. Appeals shall be forwarded to the City Clerk by the Community Development Director. *Effective Date of Appealed Actions.* Except as otherwise provided for in this Title, an action that has been appealed shall not become effective until a final determination is made by the appropriate decision making body.
